The Worst Month At The Border In DHS History

- In March, 221,303 illegal immigrants were apprehended at the southern border, **the highest number of monthly illegal border crossings in DHS history.**
 - Under Biden's watch, fiscal year 2022 is on pace to be the single worst year since Border Patrol began keeping track in 1924.
 - March's figure is a **331% increase** over the average number of March encounters under the Trump administration.
 - There have already been more encounters at the southwest border in 14 months under Biden than there were in 4 years under President Trump.
 - Over 80,000 illegal immigrants were released into the U.S. last month. During President Trump's last full month in office, there were only 17.
- When counting encounters and "gotaways," there have now been more than **3.1 million** illegal immigrant crossings since Biden took office – **larger than the population of 18 states and the city of Chicago.**
 - This figure includes over 2,499,000 illegal immigrant encounters and over 600,000 "gotaways" who have crossed the border and escaped into the country.
- Joe Biden's open border is a humanitarian and national security crisis – it's empowering drug and human traffickers, putting American families at risk, and making American communities less safe.
 - 14,167 unaccompanied children were apprehended at the border in March.
 - 88,110 illegal immigrants were apprehended from countries outside the Northern Triangle, showing that Biden's crisis has gone global.
 - Illicit drugs are flowing into the country at an alarming rate, with 1,024 pounds of deadly fentanyl and 9,583 pounds of methamphetamine seized at the southern border in March alone.
 - Annual drug overdose deaths recently reached yet another record high, with two-thirds of these deaths linked to fentanyl and other synthetic opioids.
- Biden's border crisis may get even worse: border officials are bracing for as many as 18,000 illegal immigrants per day at the border this spring.
 - Biden plans to eliminate Title 42, which will only add fuel to the fire and cause a "mass migration event."
- Biden's policies are directly to blame for the historic crisis on our border.
 - In Biden's first 100 days in office he took more than 94 executive actions on immigration, including halting construction of the border wall and ending the Trump administration's successful "Remain in Mexico" policy.
 - Illegal immigrants are thanking Biden for his weak immigration policies, saying that they "didn't even want to try" crossing the border when Trump was president.
 - Biden's recently released FY 2023 budget would cut ICE detention space for illegal immigrants by more than a quarter.

- Biden's border crisis is not "seasonal." Its "root" is not in the Northern Triangle. This is a crisis of Biden's creation – he needs to stop adding fuel to the fire.
- Democrats will pay the price at the ballot box in November when voters elect Republicans who will focus on securing our border.

Tax Day: Democrats' Favorite "Holiday"

- Today marks Tax Day, a blaring reminder that Joe Biden's proposals would raise taxes on Americans of all income levels.
- Biden's latest budget proposal includes 36 tax hikes totaling "\$2.5 trillion in new or increased taxes." If Biden gets his way, the U.S. will have the highest individual and business tax rates in the developed world.
 - Biden is pushing a likely unconstitutional tax on unrealized gains in Americans' property and businesses, which could pose huge risks to everyday investors and Americans' 401(k)s .
 - This tax hike would "enormously complicate the tax code " and grant vast power to the IRS.
 - Biden's tax hikes would result in an effective tax rate of 61 percent , nearly twice the current effective tax rate.
 - Biden's proposed budget would impose 11 new tax hikes on American energy producers , totaling over \$45 billion in new taxes, and would result in energy companies " charging more in energy delivery services."
 - Biden wants a new death tax that would crush 80,000 jobs, lower workers' wages, and shrink the U.S. economy by \$100 billion over ten years.
 - Biden's death tax would devastate family-owned farms. According to the American Farm Bureau Federation , the tax would be "devastating to American agriculture and the broader U.S. economy."
 - Biden proposed increasing the business tax rate from 21% to 28%, which would shrink the economy and eliminate 145,000 jobs.
 - According to experts, up to 100% of the cost of the corporate tax rate is ultimately passed on to workers through lower wages.
 - 31% of the corporate tax rate is ultimately passed on to consumers in the form of higher prices that hit working-class Americans the hardest.
 - In 2019, 53% of American families owned stock while 80 to 100 million Americans were invested in a 401(k), meaning Biden's business tax hike could pose a serious risk to millions of Americans and their savings.
 - Biden has even proposed letting the 2017 Tax Cuts and Jobs Act expire , which would cut the standard deduction for Americans in half.
- Biden has lied time and time again that his plan will not raise taxes on anyone making less than \$400,000 – Biden's policies are regressive and will impact lower-income Americans.
 - Biden and Democrats have proposed a tobacco tax, which will overwhelmingly affect those making less than \$400,000.
 - Under Biden's business tax increase, the bottom 20% of earners would see a drop in after-tax income .
 - According to the U.S. Chamber of Commerce, Biden's radical tax policies will "negatively [impact] " 1.4 million small businesses with less than 500 employees each.
- Not only will Biden's outright tax hikes hurt American families, but Biden's hidden tax of inflation has already cost families an additional \$3,500 in 2021 and will cost families an extra \$5,200 this year.
 - Biden is desperately trying to find a scapegoat for the inflation his policies created, but even liberal economists like Obama advisor Steven Rattner blame Biden : "*The \$1.9 trillion American Rescue Plan passed in the early days of the Biden administration will go down in history as an extraordinary policy mistake.*"
- Biden and Democrats have made it clear – they're the party of higher taxes and slower economic growth. In November, Voters will elect Republicans who will bring a halt to Democrats' wasteful spending and dreams of higher taxation.
